## **Remote Learning Trial Afternoon – Tuesday 24<sup>th</sup> November 4pm**

Next Tuesday we shall hold our remote learning trial afternoon. Your child's classroom will go live from 4pm. A teacher in the school will host a brief introduction before setting a short lesson. Please help your child to participate in the lesson, complete and return the task. If you have questions or queries during the trial, please use the stream function to communicate with the teacher. If your child attends aftercare, we shall use school iPads to participate in the trial. The teachers have prepared carefully for this event, however things may well go wrong. We shall seek feedback after the trial in order to address any difficulties that arise.

## **Remote Learning Ground Rules – Acceptable Use Policy for Remote Learning**

In order that we use the remote learning facilities as safely as possible Mr Johnston, our Computing Subject leader, has created an *Acceptable Use Policy (AUP)* for remote learning. This sets out the expectations for how Google Classroom should be used. We are sending a hard copy of this policy home with all children from Reception to Year 6 this afternoon. Nursery children will be given a copy on Monday. An electronic copy of the AUP is attached to this bulletin for your reference.

## **Christmas Under COVID**

The lead up to Christmas is always such an exciting part of the school year and very special for pupils, parents and staff. Clearly with the restrictions required for COVID safety we will not be able to run our Christmas events and services as we would normally do.

We are determined to make the best of the situation and continue in a COVID safe way to mark Christmas effectively and to include our whole school community. Our plans are evolving as I type.

## ***Nativity and Christmas Performances***

Year 1 traditionally lead the school's celebrations with a nativity service in the church. This will not be possible this year, however Year 1 will prepare a retelling of the nativity which we hope to film and photograph to share with you all later in the term.

The other year groups will also participate in a recorded retelling of the Christmas story. We aim to share this with you all either through the school's new website or through Google Classroom. The children may be asked to bring in a Christmas hat on the day they are preparing their contribution.

As ever, we need to ensure that we have correct permissions in place to include the children in these performances and recordings.

We have previously sought permission for photographs to be used in school, on our website and in marketing materials.

**I now need to ask permission for your child to be filmed and photographed as part of the education offer of the school or when performing. These films would then be placed on the school website or shared with the school community through the school's Google Classroom account.**

**If you do not give consent for filming as described above, your child will not be present in the video/audio files that we are preparing for Christmas.**

This afternoon we have sent home hard copy permission slips (an electronic copy is included with this bulletin) for you to complete and return to your child's class teacher by Friday 27<sup>th</sup> November.

## **Other Christmas Events**

### ***Christmas Cards***

The children will be able to send other children in their year group bubble and staff Christmas cards, bringing their addressed cards to their classroom from Monday 30<sup>th</sup> November. The cards will be quarantined and distributed. The final day for bringing in Christmas cards will be Tuesday 15<sup>th</sup> December, to allow time to quarantine before distribution.

### ***School Christmas Lunch***

We shall have our traditional Christmas lunch, served in classrooms, on Wednesday 16<sup>th</sup> December. The menu will be shared shortly. Children who ordinarily have packed lunch will be invited to sign up for the Christmas lunch shortly.

### ***Class Parties***

We intend to arrange COVID safe class parties. We shall seek donations of party food nearer the time. This year we will be asking for commercially produced food items that are sealed in their packaging, rather than home made contributions. These will then be shared onto 'party plates' and given to the children, rather than served in a 'buffet' style. Classes will remain in their classrooms, rather than coming together in the hall for games and the games will be adapted appropriately.

### ***Care for Others***

This year we have not been able to participate in our usual shoebox appeal. Instead, we hope to collect food donations for the Hounslow Foodbox. In this way we can support our immediate community at a particularly difficult time. We shall share further details with you later in the term.

### **Free School Meal Vouchers for the Christmas Holidays**

Families whose children receive benefits eligible free school meals will receive a £15 voucher for each week of the Christmas holidays. The voucher will be sent to your email address that we hold, as happened after the October half term. ## **Flu Vaccines**

The school nursing team will be visiting the school to deliver flu vaccines to pupils from Year 1 to Year 6 on Monday 14<sup>th</sup> December as part of the national flu vaccination programme. Parental consent is needed for every child and your child will not be included in the programme if you have not given consent. Consent is given online through the school nursing service. We sent an email to parents with details of the process on 29<sup>th</sup> September.

## **St Andrew's Day – Monday 30<sup>th</sup> November**

### **Economic Hardship as a result of COVID pandemic**

### **UK Government Call for Evidence - Faith**

The UK Government has commissioned a survey to examine how government engages with faith groups. They have launched a four-week consultation which everyone is invited to contribute to. ***This Call for Evidence aims to collect views from the public and from experts in the subject; these views will help underpin this review's recommendations.***

***The last few months have been very challenging for places of worship and people of faith. The significant restrictions that have been put in place to control the spread of the virus have limited people's ability to worship, practice and celebrate their faith as they normally would. This review began before the Covid-19 pandemic, but it is timely as the recommendations may well come to strengthen how government engages with faith groups during the Covid-19 recovery phase and beyond.***

***The call for evidence will pose a series of questions around how those of all faiths, or none, perceive the Government's engagement with faith organisations. Because the review is specifically about faith and religion, priority will be given to responses that fit within those parameters. However, space is given for respondents to share their views in a way that they feel is appropriate.***

***Colin Bloom's initial proposal is to structure the review around four main sections.***

- ***The first section asks the question, "Are faith groups, places of worship and people of faith a force for good in society?"***
- ***The second section explores the extent to which Government and its agencies have sufficient faith literacy and considers the partnership between faith groups and the State.***
- ***The third section looks at some aspects where harm might be caused through religious or faith-based practices and a review of the Government's role in tackling them.***

- ***The fourth and final section will be a set of recommendations for the Government to consider and respond to.***

***Respondents should feel free to make use of a range of sources, reports, case studies, surveys or even personal anecdotes to underpin their points where a general response is requested.***
